Bovenstaande schaatsers krijgen hierbij een formele waarschuwing. Gelieve de betrokken schaatsers op de hoogte te brengen.

De K.B.K.F. wil alle schaatsers hierbij in de eerste plaats aan het wedstrijdreglement herinneren, waarvan hieronder een uittreksel, en in het bijzonder aan de mogelijke sancties op bovenstaande inbreuken.

Les patineurs ci-dessus reçoivent un avertissement officiel. Veuillez informer les patineurs concernés.

Avant tout, pour le F.R.B.P.A. il est important de rappeler à tous les patineurs les règles des compétitions, dont un extrait, et en particulier les sanctions éventuelles sur les infractions susmentionnées.

Competition regulations (extract)

- A skater who is enrolled for a competition and who, for whatever reason, can not participate, must report to the organizing club and the national competition coordinator and this via the club secretariat.*

Non-participation without cancellation is sanctioned by the federation with a fine of € 25, invoiced to the club of allocation.

In the event of a repeat of the infringement, the penalty may be up to a maximum of € 100 and a suspension for participation in one to a maximum of three matches for which the skater is eligible to enroll.
- A skater enrolled for a competition must personally and in possession of the prescribed identity card and, if requested, also with his/her program music on CD, present him/herself at the competition secretariat and this at least one hour before the start of the category or subcategory (ie NOT just the warm up group) in which the skater participates. For the first category of the competition day this can be reduced to half an hour. This is always mentioned in the announcement.*

Late registration is, with the exception of force majeure, sanctioned for the first time by the federation with an official warning.

With each subsequent repetition, with the exception of force majeure, the skater may be sanctioned by the federation with a starting ban for the competition.
- Skaters who are coached during a competition by a trainer who does not hold a valid license to enter the restricted zone, or are being coached outside the restricted zone, can be sanctioned with a fine of € 25, invoiced to the club of allocation.*

In the event of a repeat of the infringement, the penalty may be up to a maximum of € 100 and a suspension for participation in one to a maximum of three competitions for which the skater is eligible for enroll.
- Skaters must remain present until after the formal award ceremony of the category in which they participate. Any publication of the final ranking before the award ceremony does not change this obligation of attendance.*

Absence at the award ceremony can be sanctioned by the federation with a fine of € 25, invoiced to the club of allocation.

In the event of a repeat of the infringement, the penalty may be up to a maximum of € 100 and a suspension for participation in one to a maximum of three competitions for which the skater is eligible for enroll.
